



**Participant Waiver and Release: 2025 ProStart and FCCLA Culinary Competition**

I (we) understand that I (we) hold Montana FCCLA the Montana Restaurant Association Education Foundation (“MTRAEF”), the Montana Restaurant Association, Gallatin College, Montana State University and any affiliated entity, including but not limited to the Montana Retail Association, their officers, agents and employees harmless from any and all liability or claims, which may arise out of or in connection with my (my child's or dependent's) participation in the Montana ProStart Invitational (the “Event”) and related and surrounding activities, including but not limited to mandatory or optional events. I (we) acknowledge that there is a certain risk of property damage and/or injury, including death, in any culinary education or training program and I (we) hereby agree to accept and assume any and all risks of participation, whether caused by the negligence of the Foundation or otherwise.

I (we) fully understand that participants must abide by all rules and regulations governing conduct during the Event. Any violation of these rules and regulations may result in a participant and/or attendee being sent home at participant's and/or attendee's expense. Misconduct includes but is not limited to, any alcohol or nonprescription drug use (including cigarettes and e-cigarettes) at activities or locations related to the Event. Any type of misconduct may disqualify a participant and/or the participant's team from participation in the Event and/or any awards. Should such misconduct come to the Montana FCCLA's attention, the matter will be investigated as Montana FCCLA deems appropriate. Any decision and sanction as to appropriate action due to misconduct is at the sole discretion of the Montana FCCLA and is final and non-reviewable. By participating in the Event, the student and the team accept these requirements as well as all other conditions of the Event.

I (we) hereby waive all claims for any compensation for use of my (my child's or dependent's) image, appearance, voice or likeness or for any damages related to such use.

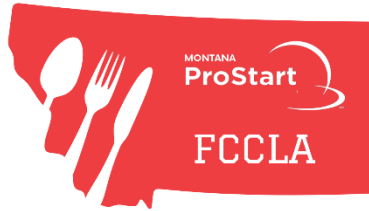
I (we) hereby waive any right that I (we) may have to inspect and/or approve the finished product or the use to which it may be applied.

Dish availability will be confirmed with your order confirmation. Dish Orders received late will be filled on a first come, first served basis and you will be informed if the style you ordered is not available.
