

State Outreach Project



Families are undoubtedly an impactful influence on who we are and what we become. That's why building strong families is so important. The Montana FCCLA State Outreach Project for 2024-25 is Families First, which means your chapters have so many opportunities to support families in your local communities.

Through a partnership with Zero to Five Montana, FCCLA chapters are eligible to receive a copy of the FCCLA National Program Families First, full of engaging activities to help chapters as they work to peer educate others about the importance of families and strategies we can implement to make them stronger.

Chapters are also encouraged to apply for mini-grants of up to \$200 to support community outreach projects designed to support local families. Thanks to the Gianforte Family Foundation for funding these grant opportunities.

Be sure to complete your State Outreach Project report by March 1 so that your chapter can showcase their Families First efforts and earn recognition. Full details about all these opportunities can be found on the [Montana FCCLA website](#).

Montana FCCLA Week of Service

Once again, Youth Service America (YSA) has teamed up with Montana FCCLA to encourage chapters to develop a plan to serve others within their communities. YSA is funding chapter outreach projects designed to serve others, with at least one component of the project happening between January 18-25.

Chapters may apply for mini-grants to fund the local outreach projects, with a maximum award of \$200. Successful projects will be student-led and encourage others in the community to get involved and help to make a positive difference alongside FCCLA members. Applications can be submitted on the [FCCLA website](#) and are due October 15. Final grant reporting is due by March 1.



Go For The Red

Did you know Montana FCCLA increased membership by 22% in 2024-25? Did you also know there is a national campaign to recognize chapters and members who are rock-star recruiters? Go For The Red is FCCLA's membership recruitment campaign. Members and chapters can win fabulous prizes simply by recruiting members and sharing how they did it [here](#). Running for District Office

For most, the idea of running for a district or sometimes even a chapter office can be nerve racking, but Montana FCCLA is here to help you! Here are the steps to becoming a district officer. The first thing you should do is communicate with your advisor. Not only is Montana FCCLA here to help, your advisor is also more than willing to assist you. Together you and your advisor can come up with a game plan for your election. Next, it is very important to look over officer duties. All district officers have different roles and responsibilities. For example, the secretary's main role is to take all district meeting minutes, the president is in charge of planning and creating an agenda for all meetings, the vice president is in charge of handling meetings in the absence of the president, and the treasurer is in charge of the finances of the district. Depending on your district there may be more or less officer positions to choose from. Another thing that is vital when running for a district office is to educate yourself on FCCLA knowledge. Before your district meeting there will be a knowledge test you have to take. This will include random FCCLA facts, national programs, competitive events, and more. You will also have to write a short speech to give in front of your district, but make sure to be creative and professional about it. It's good to make it fun to catch the audience's attention, but you still need to uphold a certain professionalism. And the last thing is to just have fun. Even if you don't end up winning your election, you should still enjoy the memories you make and appreciate the experience you gained from running for district office. To kick off the new year, Montana FCCLA is hosting a variety of contests for chapters as they Dare to Dream in the 2024-25 year!



Bulletin Board Contest--create a bulletin board in your school, following the competition guidelines, then send in a photo for voting on social media. Deadline is **September 27**



Vision Zero



Traffic safety is an issue that impacts everyone. Montana FCCLA and the Montana Department of Transportation have been partnering for years in an effort to include members in local traffic safety efforts. Our partnership continues into the 2024-25 year, with Vision Zero grants, awards, and presentations.

Look for the **Vision Zero workshops at your District Meetings**, where chapters can learn the basics about implementing a successful chapter project! Chapter leaders will also learn more about this incredible opportunity at the **Fall Leadership Rally**. Watch for the Vision Zero Toolkit for Chapters coming soon!

Develop plans now for your chapter's traffic safety outreach efforts. If you are not sure where to begin, check out some summaries from last year's projects at [this link](#). **Funding for projects is available, with a priority deadline of November 15 and a final deadline of December 6.**

After completing your project, be sure to submit the **final report by March 1** to be eligible for state-level awards.

COA and You



Hey students! Welcome back to school!

Did you have a job over the summer? Was this job in the hospitality or service industry? Do you plan to continue working at this job during the academic year? If you answered yes to these questions, you qualify to earn your Certificate of Achievement (COA for short)!! A COA requires putting in hours (you can use job hours, concession stand help, and other types of hospitality work) and mastering some skills. I bet you already have mastered many of these! Examples include: proper handwashing, showing up to work on time, measuring ingredients accurately, can count change back correctly, and many other things. While there are some specific technical and culinary skills on the list, it is not as intimidating and advanced as you might think. Earning a COA can help you stand out from other job applicants for future career opportunities. It is nationally recognized and proves that you have experience and a hard work ethic. It could even help you get paid more than a starting wage!

This IS an achievable certificate to earn, you've got this! It will benefit you in many ways if hospitality/culinary are in your future plans!

Finding a way to impact local community needs is at the heart of FCCLA. Lexie Wichman of the Moore FCCLA Chapter did exactly that with her Beef to School project titled, "Beef. It's What's For Lunch". She started at the local level and worked with her superintendent to create an application for local ranchers interested in donating a beef to the school food program and a checklist for the school Beef Committee to guide the process from year to year. Then she took it to the school board for approval and created a procurement policy for local beef and hopefully other products in the future. Lexie's efforts resulted in better school lunches for her and her peers at a reduced price to the local district. Imagine how great lunches might be all across the state with this project replicated in other districts! Lexie went on to earn first place in the nation for this project, which was also her STAR Event. 


