#### **STAR EVENTS** By Emma Harrison VP of Competitive Events

#### November STAR Event

It is about that time of the year to start picking out your STAR Event so you can compete at state, get that gold medal and go to Seattle for Nationals. There are all sorts of different categories in the STAR Events.

Once you have narrowed down what you like and what project you would like to do you need to know the requirements for the project. You need to see what grade levels are allowed to do it, if it is an individual or a group project, if it is a portfolio or display, what the limit is on pages/slides/photos/etc, and what materials you need.

There are a lot of different fine print details to a project you can't skip over. Your advisor and you need to look at the rubric together even if your advisor has done the project before, because rubrics do change. I did the Leadership project and the next year when another member did the same project they realized at the end that the whole time they were supposed to be reading and following the recommendations the book provided on how to become a better leader. Many projects require surveys, research or other ways to prove that the concern you identified in your Planning Process is a legitimate concern. You will lose points without this documentation. There are a lot of details, but they are all spelled out in the guidelines.

To not stress yourself out, look over the rubric and make sure you understand it. Some projects are really big and you have to put on an event or show the process of making your project, or you need to show your FCCLA chapter throughout the year so you need pictures. Take lots of pictures of everything - like you sewing your project, or working with other people. If you are putting on an event you need to have lots of pictures of organizing the event and the event itself. For the Chapter in Review Portfolio you need pictures of your chapter doing everything - meetings, community service, fundraising, promoting FCCLA, attending your district meeting, etc.

In every project there is also the oral presentation. Some you have 10 minutes to present, others you have 15 minutes to present your project. Do you need a paper copy of your project or can your project be electronic? Take those 30 minutes, sit down and look over your entire rubric so you know you understand it and know what you need so you are prepared to start your project.

STAR Event rubrics can be overwhelming the first time you look at them. I suggest going through each component and laying out a timeline for when you will complete that piece and who is responsible for its completion. A brief outline of what you will do for each component is also helpful. Doing your homework and laying out a plan will help you be more confident in your project. Best of luck to all of you competitors!

# NATIONAL PROGRAM SHOWCASE



The 2023-24 Montana FCCLA State Outreach Project is Financial Fitness. Your chapter can make a positive difference for others in your community by implementing an outreach project focused on helping to educate others about wise financial decisions.

Some resources that are available to chapters this year include free <u>FCCLA Financial Fitness curriculum</u> for chapters, <u>local outreach project grants</u> to fund your chapter's project, and <u>professional development</u> for advisers to help their chapters participate in the State Outreach Project. Additionally, chapters submitting a report by March 1 are eligible to win a state award for their project. Some ideas for a Financial Fitness Outreach Project might include:

- Ask students to collect financial wisdom across the generations; compile into a bulletin board to highlight the influence of others on our spending.
- Compare costs of dining out with costs of preparing the same meals at home; create a cookbook full of restaurant recipes and share at a local grocery store.
- Host a consumer night, where members research consumer issues and share displays with their findings; add snacks and an electronic game as you welcome the public and increase their consumer awareness.
- Research children's books with financial messages; visit an elementary school to read with children and influence their future spending habits.

Montana is currently ranked 29/50 states in terms of financial literacy access (source: Montana Office of Public Instruction). Improved education results in better financial options for Montana individals and families.

Although the Class of 2026 is required to complete a financial literacy course before graduation, Montana FCCLA has the tools ready now to teach others about earning, spending, saving, and protecting their finances.

Chapters can apply for mini-grants of \$200 to help chapters develop and implement projects to help others better understand financial management. Chapters completing the final report about their efforts are eligible to win cash awards of \$500, \$300 or \$200! Chapters may also apply to receive FREE Financial Fitness curriculum!
