Additional conference plans include the College and Career Readiness Fair on Thursday afternoon, where members meet representatives to learn more about options after high school, as well as resources available to enhance member and chapter success now! Culinary competitions, including ProStart and FCCLA, also take place on Thursday, as well as our opening session where we will meet the keynote speaker. Friday activities include opportunities to participate in outreach projects, meeting our state officers at Montana Mayhem, and the closing recognition session. Attendees should expect to meet dynamic session presenters and compete in fun challenges during both days.

While some details are still being finalized for the conference, expect all the information on our <u>website</u> by December 19. Regular registration will open at the lowest rate (\$75) January 4-19, with final registration (\$100) closing on February 4. **No registrations will be accepted once final registration closes.**

Fifty high school students and twelve teachers from across Montana participated in the Montana ProStart/FCCLA Culinary Camp, held November 3 at Sysco Montana in Billings. The event provided handson learning and career exploration for students interested in culinary arts and hospitality careers while giving educators a chance to sharpen their own skills in a professional setting.

In the afternoon, both teachers and students teamed up for a marketing challenge, designed to strengthen communication, creativity, and business skills that align with the ProStart

An optional networking dinner the evening before the event allowed participants to build connections, with attendees dining at Walker's Grill and The Montana Club in Billings.

Support from Sysco Montana and the Montana Pork Producers Council was essential to the success of the event. Their partnership provided valuable resources, instruction, and mentorship that helped bridge the gap between classroom learning and real-world industry experience.


#### 2025-26 Membership Affiliation Options






